The race will begin and end at Nautilus Fitness Center Executive at 618 S. Madison Street. A water stop will be provided at the turn around point at 1409 Pinckney Street, Whiteville, NC.

PARTICIPATION, LIABILITY WAIVER, ASSUMPTION OF THE RISK, AND  
INDEMNIFICATION AGREEMENT

In consideration for being allowed by North Carolina Pecan Harvest Festival and to participate in the NC Pecan Harvest Festival 5K Walk/Run (hereafter referred to as "Event") undersigned hereby agrees as follows:

I (or my minor child, if I am signing as parent/guardian) do hereby affirm and acknowledge that I (or my minor child, if I am signing as parent/guardian) am participating in the Event for my own personal benefit. I (or my minor child, if I am signing as parent/guardian) understand that I (or my minor child, if I am signing as parent/guardian) will participate in recreational activities as part of the Event, and that such activities have inherent dangers and physical risks. I (or my minor child, if I am signing as parent/guardian) understand and acknowledge that the inherent dangers and physical risks involved in these activities are such that that no amount of care, caution, instruction or expertise can eliminate. These dangers and risks include, but are not limited to, loss or damage of personal property, broken bones, strains, sprains, bruises, heart attacks, heat exhaustion, concussions, and other personal injuries, or even death, that could result from tripping, falling, contact with other individuals, the conditions of road surfaces, failure of other participants, vehicles, and non-participants to observe traffic signals or laws, exposure to temperature extremes or inclement weather, sun hazards, equipment failure, and vehicle accidents while traveling to and from the activity site. I (or my minor child, if I am signing as parent/guardian) assume responsibility for all risks, known and unknown, involved to me and my property in the aforementioned activities, and I (or my minor child, if I am signing as parent/guardian) am voluntarily participating in reliance upon my own judgment and knowledge of my own experience and capabilities.

I (or my minor child, if I am signing as parent/guardian) understand that the determination of my ability to participate in the Event should be made by my physician if necessary. I (or my minor child, if I am signing as parent/guardian) understand that I need the approval of a physician if I (or my minor child, if I am signing as parent/guardian) am uncertain as to my physical fitness for the rigors of this Event. I (or my minor child, if I am signing as parent/guardian) understand that I

(or my minor child, if I am signing as parent/guardian) may be required to seek approval from a physician if there is a health or safety question relative to my condition before being allowed to participate in the Event. I (or my minor child, if I am signing as parent/guardian) further understand that treatment for any medical problems I (or my minor child, if I am signing as parent/guardian) may suffer is my responsibility and will be paid by me and/or covered by my insurance.

I (or my minor child, if I am signing as parent/guardian) shall indemnify and hold harmless NC Pecan Harvest Festival and Nautilus Fitness Center Executive, their trustees, officers, directors, employees and agents from any liability, losses, costs, damages, claims or causes of action of any kind or nature whatsoever, and expenses, including attorneys fees, arising from or proximately caused by my participation in this Event, including any travel. I (or my minor child, if I am signing as parent/guardian) further agree to accept and assume for myself, my assigns, executors, and heirs any and all such risks and losses that may occur.

I (or my minor child, if I am signing as parent/guardian) have read the Event's rules and regulations and hereby accept the regulations of the Event described therein. I (or my minor child, if I am signing as parent/guardian) understand that the Event has the authority to establish and enforce other regulations in addition to these.

I (or my minor child, if I am signing as parent/guardian) further agree that this agreement shall be governed by and interpreted in accordance with the laws of the State of North Carolina. The terms of this agreement are severable such that if one or more provisions are declared illegal, void or unenforceable, the remainder of the provisions shall continue to be valid, enforceable, and binding upon the parties.

I (or my minor child, if I am signing as parent/guardian) understand that this is a legal document which is binding on me, my heirs and assigns and on those who may claim by or through me. I (or my minor child, if I am signing as parent/guardian) am eighteen years of age or older, and have full capacity to enter into this agreement and do so voluntarily.
